Early Learning Centre Fee Schedule

BPCS has received Service Approval for our Early Learning Centre (ELC).

All families who are eligible for Child Care Subsidy (CCS) need to apply through Services Australia directly to receive a rebate on these fees.

Please note, our Application Fee is charged exclusive to the CCS, and must be paid at the time of application.

Wilderness Playgroup Fees

Infrastructure Levy

The BPCS Infrastructure Levy assists the school in meeting the lease of the site and maintenance of the buildings and grounds. This is compulsory and non-tax deductible.

Resource Levy

Parents are not required to supply books or stationery. A fee for a portfolio and resources used in the school program is included in the first instalment of fees as follows:

Annual Fees

Consist of tuition fees, infrastructure levy and resource levy. You can elect to pay annual fees in monthly instalments over a ten-month period or in three instalments as detailed below. Fortnightly (20 payments via direct debit is available on request).

Family Discounts

Other Charges

- Incidental costs through the year such as excursions and camps will be charged at the time.
- 0.57% fee is charged for all BPCS Visa and Mastercard transactions and 1.5% fee is charged for AMEX. Subject to Change (may be subject to change based on fees charged to BPCS by the Banks).

Notice of Withdrawal Pre-Primary to Year 12

Written notice must be provided by the last day of the previous term prior to the student leaving in order to withdraw a student; that is, one full term plus school holidays written notice must be given. If an Endowment Fee has been paid and in default of this notice, 10% of the Total Annual Fee (Tuition and Infrastructure Levy) will be payable 30 days from invoice.

Notice of Withdrawal Wilderness Playgroup

Written notice of four (4) weeks is required if a decision is made to withdraw from the Bold Park Community School Wilderness Playgroup. Please note that term fees will not be refunded.

Deposits

Prior to 2017, a deposit system was in place. This section refers to families who fall under the deposit system (which no longer applies for students enrolled from 2017):

Failure to provide written notice as outlined under 'Notice of Withdrawal' above will result in the forfeiture of the deposit.

- Eligible deposits will be refunded to families within three months of leaving the school.

NB: Under no circumstances is the deposit to be offset against tuition fees or building levy.

Payment of Fees and Outstanding Accounts

In accordance with the BPCS School Fee Policy

- Any Pre-Primary to Year 12 accounts not paid by one of the above options by the due date may incur an account administration fee until paid.
- All debt collection fees will be added to the family school fee account to cover this cost for all accounts that are not paid within the guidelines outlined within this Fee Schedule and the BPCS School Fee Policy.
- No refunds will be made for term fees if a student leaves or changes programs at any time during a term i.e. fees are payable for the full term regardless of attendance.

Pre-Primary to Year 12 Payment of Fees Schedule

Fee accounts are invoiced three (3) times per year, Instalment 1 (January), Instalment 2 (April) and Instalment 3 (July) and are payable on 1 February, 1 May and 1 August respectively each year.

Secondary Assistance Scheme

A means tested assistance scheme administered by the Department of Education may be available to parents who hold eligible concession cards. It comprises an education program allowance and a clothing allowance.

Applications must be submitted to the Department of Education in the first term of each year that the parents are eligible. Application forms are available from the School by contacting the Business Manager (business@boldpark.com).

School Uniform

School uniform is compulsory for all full-time students, and optional for part-time students. However, we do recommend that children attending part-time have a school polo shirt, windcheater and a school hat for use on excursions so they are easily identified.

For full-time students in the Early Childhood and Primary years the uniform consists of a 'primary' coloured polo shirt, windcheater and school hat.

For students in Middle School and College the uniform consists of the navy blue polo shirt, hat, hoodie and windbreaker (winter use). Year 12 students also have the option of wearing their 'Leavers' jacket during their graduation year.

There are additional optional items that can be purchased such as cargo shorts and pants, sport shorts and skorts. Hats must be worn during outside play and appropriate footwear is required for Bluearth, Kitchen Garden, the Wildspace, the Science Lab and excursions including lake walks.
